## **SECTION – A**

### **INTRODUCTION & OBJECTIVE OF THE PROJECT**

As a part of BEUP, (“Bidhayak Elaka Unnayan Prakaalpa” (BEUP) was introduced by the Government of West Bengal in the financial year 2000-2001) it is decided to setup high mast solar powered lights in multiple locations across the District of Purulia. The TENDER intends to select/empanel eligible and capable bidders to supply, install, implement and maintain the high mast lights for a period of 5 years in selected locations. The project is aimed at improvement of facilities under the local area for purpose of development, improvement of security for the local population.

The purpose of the TENDER shall be to select capable service providers with required experience, technical and financial capabilities, and adequate local facilities, to implement the project. The project shall be implemented in Phases and the first phase shall comprise of 09 locations within the district. The TENDER shall evaluate the technical and commercial capabilities of responsive bidders, and empanel one or more contractors for similar scope of work. The first phase shall be awarded to the lowest bidder who shall be found to be technically and commercially eligible. For further phases, WTL reserves the right to empanel eligible bidders for award of work, if they match the price bid of the lowest bidder. The work in the first phase shall comprise of:

Installation of 10.5 Mtr. Solar High-mast Light with 6 Nos. 50-Watt LED Light fittings, at the following:

5. At near Kushtuka Shiv Mandir, Vill: Kushtuka, GP: Agoya- Narrah, Block: Purulia-II

### SCOPE OF WORK & RESPONSIBILITY

The project shall be implemented in multiple phases. The purpose of this TENDER shall be to select eligible bidders with necessary technical and financial capabilities to implement the Phase one of the project. The Phase II shall comprise of the implementation of 10.5 Mts 09 Nos. High Mast Solar enabled lights in 09 locations across the district of Purulia.

Key responsibilities of the successful bidder, but not limited to, are as follows:

- Supply of all components of the High-mast Lights as per specification below
- Installation and commissioning of High Mast Solar lights in 09 locations as specified.
- Support and maintenance of High Mast Solar lights in 09 locations for 5 years from the date of commissioning.

2. The bidder should have their presence in West Bengal with own office. Valid proof should be submitted along with bid.

4. The bidder having sufficient experience and credentials for successful installation and commissioning of High Mast Lights in West Bengal for at least 20 Units in the last five years at the end of 31st March 2025. Copy of order & completion certificate/Payment received statement to be submitted.
5. The bidder should have completed minimum 3 projects in the field of High Mast Lights installation in West Bengal, in the last 3 years. Copy of order to be submitted.
6. The bidder should have aggregate annual turnover not less than 1 Crore (Rs. One Crore only) in 05 (Five) financial years FY – 2019-20, 2020-21, 2021-22, 2022-23, 2023-24. Bidder shall have to submit Audited Balance Sheet / Audited Accounts / Auditor Certificate in support of their claim.
7. The Bidder should have positive net worth last financial year 2023-24. Auditor Certificate in support of their claim to be submitted.
8. The bidder shall submit Bid Form (Section – F) in letter head duly signed by the authorized signatory of the company as per the format enclosed. Deviation in format may not be accepted.
9. “**Bidder**” means any firm offering the solution(s), service(s) and /or materials required in the RFP. The word Bidder when used in the pre award period shall be synonymous with Bidder, and when used after award of the Contract shall mean the successful Bidder.

“**Contract**” is used synonymously with Agreement.

“**Contract Price**” means the price to be paid to the Contractor for providing the Solution, in accordance with the payment terms.

“**Contractor**” means the Bidder whose bid to perform the Contract has been accepted by Tender Committee and is named as such in the Letter of Award.

“**Default Notice**” shall mean the written notice of Default of the Agreement issued by one Party to the other.

“**Installation**” shall means Supply & Installation and Implementation of High Mast Solar Lights Items.

“**Fraudulent Practice**” means a misrepresentation of facts in order to influence a procurement process or the execution of a Contract and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid prices at artificial noncompetitive levels and to deprive across Purulia District under Bidhayak Elaka Unnayan Prakalpa (BEUP) 2024-25

“**Good Industry Practice**” shall mean the exercise of that degree of skill, diligence and prudence which would reasonably and ordinarily be expected from a reasonably skilled and experienced Operator engaged in the same type of undertaking under the same or similar circumstances.

“**Government**” / “**Gov. of W. Bengal**” means the Government of West Bengal.

“**GoI**” shall stand for the Government of India.

“**GoWB**” means Government of West Bengal

“**Similar Nature of Work**” means Supply & Installation and Implementation of High Mast Solar Lights Items.

“**Project**” means Supply, Installation and Implementation of High Mast Solar Lights with 5 (Five) years warranty across Purulia District under BEUP 2024-25.

“**Services**” means the work to be performed by the Bidder pursuant to this Contract, as described in the detailed Scope of Work.

“**Interest rate**” means “364 days Government of India (GoI) Treasury Bills” rate.

"**Law**" shall mean any Act, notification, bye law, rules and regulations, directive, ordinance, order or instruction having the force of law enacted or issued by the Central Government and/or the Government of West Bengal or any other Government or regulatory authority or political subdivision of government agency.

"**LOI**" means issuing of Letter of Intent shall constitute the intention of the WTL to place the Purchase Order with the successful bidder.

"**Operator**" means the company providing the services under Agreement.

"**Service Down Time**" (SDT) means the time period when specified services with specified technical and operational requirements as mentioned in section titled "WARRANTY SUPPORT" are not available to Gov. of West Bengal and its user departments and organizations.

"**WTL**" means Webel Technology Limited a Govt. of West Bengal undertaking.

"**WP**" means Watt peak.

## 2. PRE BID MEETING

Only the queries received within the stipulated date prior to the Pre Bid Meeting will be answered. Interest bidders are requested to send mail to (purchase@wtl.co.in) for participation of online pre-bid meeting Based on request WTL will share meeting id / links for meeting. If there is any change in date and time, then will inform.

## 3. COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of the bid and WTL will no case be responsible for those costs regardless of the conduct or outcome of the bidding process.

## 4. BID DOCUMENT

Bidder is expected to examine all instructions, forms, terms and requirement in the bid document. The invitation to bid together with all its attachment thereto shall be considered to be read, understood and accepted by the bidder unless deviations are specifically stated in the seriatim by the bidder. Failure to furnish all information required by the bid document or a bid not substantially responsive to the bid document in every respect may result of the bid.

## 5. AMENDMENT OF BID DOCUMENT

At any time prior to the deadline for submission of proposals, WTL reserves the right to add/modify/delete any portion of this document by issuance of an Corrigendum, which would be

## 6. MODIFICATION AND WITHDRAWAL OF BIDS

As per the bidding process available in the tender. The bidder cannot modify or withdraw its bid after submission.

## 7. LANGUAGE OF BID & CORRESPONDENCE

The proposal will be prepared by the Bidder in English language only. All the documents relating to the proposal (including brochures) supplied by the firm should also be in English, and the correspondence between the Bidder & WTL will be in English language only. The correspondence by fax/E-mail must be subsequently confirmed by a duly signed formal copy.

## 8. BIDDER'S SOLUTION

The bidders are requested to study the Bill of Material supplied with this document carefully. While working out the solution the bidder has to work with the broad minimum specification provided in the tender documents, conforming to the model, make and Part number (wherever provided). While submitting the bid the bidder has to detail out all components needed to complete the system BOM. The bidder is required quote for each item retaining all major components/sub system detailed and specified. As the contractor will be responsible for smooth functioning of the system, availability of spares during the tenure of the warranty period have to be take care by the contractor to maintain the guaranteed uptime.

## 9. EARNEST MONEY DEPOSIT (EMD) / TENDER FEE

The bidder shall furnish Online Receipt against payment of Tender Fees and Earnest Money Deposit

## 10. REFUND OF EMD

EMD will be refunded to the unsuccessful bidders without interest by following guidelines of circular 3975-F(Y) dated 28/07/2016 on final selection of Successful Bidders.

## 11. FORFEITURE OF EMD

EMD made by Bidder may be forfeited under the following conditions:

If Bidder withdraws the proposal before the expiry of validity period.

During the evaluation process, if a Bidder indulges in any such activity as would jeopardize the process, the decision of WTL regarding forfeiture of EMD shall be final and shall not be called upon question under any circumstances.

If Bidder violates any of the provisions of the terms and conditions of the proposal.

In the case of a successful Bidder, if Bidder fails to:

- a) Accept the work order along with the terms and conditions.
- b) Furnish performance security.
- c) Violates any of the work conditions of this proposal or indulges in any such activities as would jeopardize the work.
- d) Submitting false/misleading information/declaration/documents/proof/etc.

The decision of WTL regarding forfeiture of EMD shall be final and shall not be called upon to question under any circumstances, besides, forfeiture of EMD even the Bidder will be deferred from participating in any job for a period of one year.

## 12. FORMS AND FORMATS

The various inputs for the Techno Commercial as Financial Bids are to be submitted in the format specified. The bidder shall use the form, wherever specified, to provide relevant information. If form does not provide space for any required information, space at the end of the form or additional sheets shall be used to convey the said information. For all other cases, the bidder shall design a form to hold the required information.

## 13. LACK OF INFORMATION TO BIDDER

The bidder shall be deemed to have carefully examined the Bid document to his entire satisfaction. Any lack of information shall not relieve the bidder of his responsibility to fulfill his obligation under the bid. If bidder has any queries relating to bid document then he can send the queries before the Pre Bid Meeting.

## 14. CONTRACT EXECUTION

On receipt of the Letter of Award the contractor should submit a Performance Bank Guarantee (PBG) equivalent to 10% of the total contract value within three weeks from the date of receipt of Letter of Award/Order. The PBG should be valid for six month more than the warranty period. All delivery of the material will have to be completed within 45 days from the date of acceptance of contract and the contractor has to ensure all activities leading to the commissioning of the contract to be completed within 75 days from the date of award. ## 15. TIME SCHEDULE FOR DELIVERY

## 16. LIQUIDATED DAMAGE / PENALTY
