### **SCOPE OF WORK & RESPONSIBILITY**

Finance Department, Govt. of West Bengal desires to have Digital Signature certificates for all the Drawing & Disbursing Officers and e-Tender inviting officers of the State Government for use in connection with various modules of Integrated Financial Management System for online submission of bill to the treasury and e-payment against the bill to the beneficiary as well as for e-Tender procedure and other Online portal. Webel Technology Limited (WTL) will do the empanelment of service providers from licensed Certifying Authorities of Controller of Certifying Authorities (CCA), Govt. of India or Authorized service partner of any reputed CCA for Supply of Digital Signature Certificate with USB Token.

After completion of e-tendering process the Finance Department will publish list of empanelment list.

#### **REQUIREMENT:**

Digital Signature Certificate, Class-III, with Dongle. The required quantity is approximately 13000 nos. The final quantity may vary. The validity of certificate should be of two years from the date of issue and renewable thereafter.

#### **DONGLE:**

The Digital Signature and Dongle will be used in the IFMS Modules, WB e-Tender/e-Auction modules, WB Health Scheme and other online Applications / Portal. Single dongle will be used both for IFMS modules and e-tender/e-auction process.

#### **OTHERS:**

The requirement of DSC is all over West Bengal. The selected vendor will need to distribute the DSC along with Dongle in Kolkata and all districts throughout West Bengal in coordination with the District Nodal Officers to be designated for the purpose.

## **SECTION – C**

### **ELIGIBILITY CRITERIA OF BIDDERS**

1. The Bidder / Vendors authorized by the Controller of Certifying Authorities (CCA), Government of India for issuing Digital Signature Certificate to end user are only eligible to participate in this tender. Valid and upto date Authorisation Certificate should be submitted.
2. The bidder / Vendor should have their presence in Kolkata own their own office. Valid proof (Trade License/GST Certificate and other valid documents) should be submitted along with the bid.
3. The bidder / Vendor should have valid GST Registration Certificate, PAN & Trade License. Bidder shall have to submit photocopy of the documents.
4. The Bidder / Vendor should have an annual turnover of not less than Rs.25.00 Lakh each year in the last three financial years (FY – 2022-23, 2023-24 & 2024-25). Bidder shall have to submit Audited Accounts / Auditor Certificate in support of their claim.
5. The bidder / Vendor shall submit Bid Form (Section – H) duly signed by the authorized signatory of the company as per the format enclosed. Deviation in format may not be accepted.
6. Bidder / Vendor shall submit NIT Declaration (Section - L) duly signed by the authorized signatory of the company as per the format. Deviation in format may not be accepted.
7. The bidder shall not have been blacklisted by any State/Central Government or PSU Organization or bilateral/multilateral funding agencies for breach of ethical conduct or fraudulent practices as on date of submission of the proposal. Declaration on bidder's letter head to be submitted.

## SECTION – D

### INSTRUCTIONS TO BIDDER

#### 1. Definitions

In this document, the following terms shall have following respective meanings:

“**DSC**” means Digital Signature Certificate.

“**Contract Price**” means the price to be paid to the selected empaneled bidder for providing the service / material, in accordance with the payment terms.

“**Bidder**” means any firm offering the service and /or materials required in the RFP. The word Bidder when used in the pre award period shall be synonymous with Bidder, and when used after award of the Contract shall mean the successful Bidder.

“**Similar Nature**” means execution of job for completion for Digital Certificate

“**Fraudulent Practice**” means a misrepresentation of facts in order to influence a procurement process or the execution of a Contract and includes collusive practice among Bidders designed to establish Bid prices at artificial non-competitive levels and to deprive the Finance Department and eventually GoWB of the benefits of free and open competition.

“**GoI**” shall stand for the Government of India.

“**GoWB**” means Government of West Bengal.

“**Law**” shall mean any Act, notification, bye law, rules and regulations, directive, ordinance, order or instruction having the force of law enacted or issued by the Central Government and/ or the Government of West Bengal or regulatory authority or political subdivision of government agency.

“**Service**” means provision of Contracted service viz., maintenance and associated services for DEPLOYED SYSTEMS.

“**Termination Notice**” means the written notice of termination of the contract issued by WTL

“**FD**” means Finance Department, GoWB.

“**WTL**” means Webel Technology Limited a Gov. of W. Bengal undertaking.

#### 2. Pre Bid Meeting

Pre Bid Meeting will be held on 10.02.2026 at 12.00 hrs. (**On-Line Meeting**). Bidder can send their queries as per format (Section - K) to Manager (Purchase) ([purchase@wtl.co.in](mailto:purchase@wtl.co.in)). Only the queries received within the stipulated date prior to the Pre Bid Meeting will be answered. Interest bidders are requested to send mail to ([purchase@wtl.co.in](mailto:purchase@wtl.co.in)) for participation of online pre-bid meeting Based on request WTL will share meeting id / links for meeting. If there is any change in date and time then will inform.

#### 3. Earnest Money Deposit (EMD) / Tender Fee

The bidder shall furnish Online Receipt against payment of Tender Fees and Earnest Money Deposit.

#### 4. Refund of EMD

EMD will be refunded to the unsuccessful bidders without interest by following guidelines of circular 3975-F(Y) dated 28/07/2016 on final selection of Successful Bidders.

#### 5. Cost of Bidding

The bidder should bear all costs associated with the preparation and submission of the bid and WTL will in no case be responsible for those costs regardless of the conduct or outcome of the bidding process.

## **6. Awarding of Contract**

After evaluation of eligibility criteria and Technical specification, qualified bidders will only be considered for Financial Bid evaluation

**Line-item-wise, the L1 bidder & next two bidders will be considered for empanelment at the Line-item-wise L1 price. The respective Department / Directorate/Other Organisation of GoWB will select the service provider from the empanelled list. The Finance Department will publish the Government Order of the empanelment list.**

## **7. Time Schedule for Delivery**

Digital Signature Certificate Installed / loaded USB Tokens to be delivered within 10 days from the date of receipt of Application Form for the Certificate by selected vendors.

## **8. Terms of Payment**

Payment will be made by respective Department / Directorate, GoWB.

## **9. Validity of DSC & Dongle**

Digital Signature Certificate should be valid for two years and may be renewed thereafter and two years warranty for Dongle.

## **10. Validity of Price**

The quoted price should be valid for two years from the date of Price Bid Opening. The DSC along with USB Token should be supplied by the selected vendor at the same price during the price validity period.

## **11. Taxes & Duties**

- The prices should be inclusive of all taxes & levies including GST. However the rate and quantum of taxes should be indicated separately in the Price Bid submitted / bill.

## **12. Price**

- Price should be quoted in the BOQ format only. No deviation in any form in the BOQ sheet is acceptable.
- Price quoted should be firm, inclusive of packing, forwarding, insurance & freight charges.
- Percentage/specified amount of taxes & duties should be clearly mentioned otherwise WTL reserves the right to reject such vague offer.

## **13. Bid Document**

Bidder is expected to examine all instructions, forms, terms and requirement in the bid document. The invitation to bid together with all its attachment thereto should be considered to be read, understood and accepted by the bidder unless deviations are specifically stated in the seriatim by the bidder. Failure to furnish all information required by the bid document or a bid not substantially responsive to the bid document in every respect may result in the bid being summarily rejected.

## **14. Amendment of Bid Document**

At any time prior to the deadline for submission of proposals, WTL reserves the right to add/modify/delete any portion of this document by issuance of Corrigendum, which would be published on the website and will also be made available to the all the Bidder who have been issued the tender document. The Corrigendum should be binding on all bidders and will form part of the bid documents.

## **15. Modification and Withdrawal of Bids**

As per the bidding process available in the tender.

## **16. Language of Bid & Correspondence**

The proposal will be prepared by the Bidder in English language only. All the documents relating to the proposal (including brochures) supplied by the firm should also be in English, and the correspondence between the Bidder & WTL will be in English language only. The correspondence by fax/E-mail must be subsequently confirmed by a duly signed formal copy.

## **17. Forms And Formats**

The various inputs for the Bid are to be submitted in the format specified. The bidder shall use the form, wherever specified, to provide relevant information. If form does not provide space for any required information, space at the end of the form or additional sheets should be used to convey the said information. For all other cases, the bidder shall design a form to hold the required information.

## **18. Lack of Information to Bidder**

The bidder should be deemed to have carefully examined the Bid document to his entire satisfaction. Any lack of information shall not in any way relieve the bidder of his responsibility to fulfill his obligation under the bid.

## **19. Liquidated Damage**

The job includes the supply of materials mentioned in the tender document. In the event of failure to meet the supply in stipulated date/time liquidated damage may be imposed on the contractor for sum not less than 0.5% of the contract value for undelivered items, each week or part thereof, subject to a ceiling of 10% of the total contract value (Excluding all taxes & duties and other charges). In the event of LD exceeds 10% of the order value, WTL reserves the right to terminate the contract and WTL will get the job completed by any other competent party. The difference of cost incurred by WTL will be recovered from the contractor from the pending bill.

## **20. Governing Laws**

This contract should be governed by and interpreted by Arbitration clause in accordance with Laws in force in India. The courts at Kolkata shall have exclusive jurisdiction in all matters arising under the contract. The selected vendor shall keep himself fully informed of all current national, state and municipal law and ordinances. The selected vendor shall at their own expense, obtain all necessary permits and license and pay all fees and taxes required by law. These will be selected vendor's entire obligation regarding any claim of infringement. The selected vendor hereto agrees that it shall comply with all applicable union, state and local laws, ordinances, regulations and codes in performing its obligations hereunder, including the procurement of licenses, permits certificates and payment of taxes where required. The selected vendor shall establish and maintain all proper records (particularly, but without limitation, accounting records) required by any law, code/practice of corporate policy applicable to it from time to time including records and returns as applicable under labor legislation.

## **21. Corrupt or Fraudulent**

The Tender Committee requires that the bidders under this Tender observe the highest standards of ethics during the procurement and execution of such contracts. For this purpose the definition of corrupt and fraudulent practices will follow the provisions of the relevant laws in force. The Tender Committee will reject a proposal for award if it detects that the bidder has engaged in corrupt or fraudulent practices in competing for the contract in question. The Tender Committee will declare a firm ineligible, either indefinitely or for a stated period of time, if it at any time determines that the firm has engaged in corrupt and fraudulent practices in competing for, or in executing, a contract.

## **22. Binding Clause**

All decisions taken by the Tender Committee regarding the processing of this tender and award of contract shall be final and binding on all parties concerned. The Tender Committee reserves the right:

- To vary, modify, revise, amend or change any of the terms and conditions mentioned above and,
- To reject any or all the Tender/s without assigning any reason whatsoever thereof or to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for such decision.

## **23. Termination for Default**

WTL may without prejudice to any other remedy or right of claim for breach of contract by giving not less than 30 days written notice of default sent to the contractor, terminate the order in whole or in part. If the contractor materially fails to render any or all the services within the time

period specified in the contract or any extension thereof granted by WTL in writing and fails to remedy its failure within a period of thirty days after receipt of default notice from WTL.

## **24. Warranty**

The contractor will warranty that products supplied under the contract are newly made and are free from defects in the design and workmanship. The Contractor would be responsible for the up keep and maintenance of the product. The warranty period should be mentioned in the bid. Service support for DSC along with USB Token should be provided by the selected vendor for two years from the date of issuance of DSC.

## **25. No waiver of Rights**

Neither the inspection by WTL or any of their agents nor any order by WTL for payment of money or any payment for or acceptance of the whole or any part of the works by WTL, nor any extension of time, nor any possession taken by WTL shall operate as a waiver of any provision of the contract or of any power reserved to WTL, or any right to damages here in provided, nor shall any waiver of any breach in the contract be held to be a waiver of any other subsequent breach.

## **26. Enforcement of Terms**

The failure of either party to enforce at any time any of the provision of this contract or any rights in respect thereto or to exercise any option herein provided shall in no way be construed to be a waiver to such provisions, rights or options or in any way to affect the validity of the contract. Failure to exercise by either party of any of its rights herein shall not preclude or prejudice either party from exercising the same or any other right it may have hereunder.

## **27. Discrepancies in Bid**

- Discrepancy between description in words and figures, the rate which corresponds to the words quoted by the bidder should be taken as correct.
- Discrepancy in the amount quoted by the bidder due to calculation mistake of the unit rate then the unit rate should be regarded as firm.
- Discrepancy in totaling or carry forward in the amount quoted by the bidder should be corrected.

## **28. Opening of Bid by WTL**

Bids shall be opened and downloaded electronically through operation of the process in the e-Tender portal in presence of Tender Committee. Bidders interested to remain present during electronic bid opening may attend the bid opening session at WTL premises at scheduled date & time.

## **29. Contacting WTL**

Bidder shall not approach WTL officers beyond office hours and/or outside WTL office premises from the time of the Bid opening to the time of finalization of successful bidder. Any effort by bidder to influence WTL office in the decision on Bid evaluation, Bid comparison or finalization may result in rejection of the Bidder's offer. If the bidder wishes to bring additional information to the notice of WTL, it should be in writing following the procedure mentioned hereinabove.

## **30. WTL's Right to Reject any or all Bids**

WTL reserves the right to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected bidder(s) or any obligation to inform the affected bidder(s) of the grounds for such decision.

## **31. Bid Currencies**

Prices should be quoted in **Indian Rupees**, inclusive of all prevailing taxes, levies, duties, cess etc.

## **32. Canvassing**

Canvassing or support in any form for the acceptance of any tender is strictly prohibited. Any bidder doing so will render him liable to penalties, which may include removal of this name from the register of approved selected vendor.

## **33. Non-Transferability of Tender**

This tender document is not transferable.

## **34. Preparation of Tender**

Tender should be submitted in accordance with the following instructions:

- (i) Tenders should be submitted in the prescribed forms. Digital signatures should be used. Where there is conflict between the words and the figures, the words shall prevail.
- (ii) All notations must be in ink or type written. No erasing or overwriting will be permitted. Mistakes may be crossed out and corrections typed or written with ink adjacent thereto and must be initialed in ink by the person or persons signing the tender.
- (iii) Tender bids should be submitted as per the time schedule given in Section A.
- (iv) Tender bids made subject to any conditions or stipulations of the bidder are liable to be rejected.
- (v) Each and every page of the tender document must be signed with company seal by the bidder.

## **35. Clarification of Bid**

During evaluation of the bids, the Customer/Tender Committee, at its discretion may ask the bidder for clarification of its bid. The request for the clarification and the response should be in writing (fax/email). No change in the quoted bid price is permitted

## **36. Compliance with Law**

The selected vendor hereto agrees that it shall comply with all applicable union, state and local laws, ordinances, regulations and codes in performing its obligations hereunder, including the procurement of licenses, permits certificates and payment of taxes where required. The contractor shall establish and maintain all proper records (particularly, but without limitation, accounting records) required by any law, code/practice of corporate policy applicable to it from time to time including records and returns as applicable under labor legislation.

## **37. Erasures or Alternations**

The offers with overwriting and erasures may make the tender liable for rejection if each of such overwriting/erasures/manuscripts is not signed by the authorized signatory of the bidder. The Customer may treat offers not adhering to these guidelines as unacceptable. The Customer may, at its discretion, waive any minor non-conformity or any minor irregularity in the offer. This should be binding on all bidders and the Tender Committee reserves the right for such waivers.

## **38. General Terms**

- (i) All the pages of the bid document including documents submitted therein must be duly signed and stamped failing which the offer should be liable to be rejected.
- (ii) All the documents to be submitted by the bidder along with their offer should be duly authenticated by the person signing the offer and if at any point of time during procurement process or subsequently it is detected that documents submitted are forged/tampered/manipulated in any way, the total responsibility lies with the bidder and WTL reserves the full right to take action as may be deemed fit including rejection of the offer and such case is to be kept recorded for any future dealing with them.
- (iii) No Technical/Commercial clarification will be entertained after opening of the tender.
